◆ Sales Volume Calculation Method:

Personal AGM Organization Volume X 100%

First Generation AGM Organization Volume X 60%

Second Generation AGM Organization Volume X 40%

Third Generation AGM Organization Volume X 20%

◆ The following 2 criteria must be achieved to attain the AGM Annual Awards:

- The calculation is based on the qualifying first generation AGMs (qualifying First Generation AGM refers to downline AGM with Group Volume of at least RM36,200 in one single country), AGM's own Organization Volume must qualify for the following volume:

- AGM has to achieve an Annual Group Volume of at least RM36, 200 in one single country.

If awardees are qualified for both NET or AGM Annual Awards, they will not be eligible for AGM Sales Award °
