
- i. Achievers of the 2025 AGM Decamillion Master Performance Award and above may extend an invitation to one participating guest (restricted to

**Terms and Conditions:**

1. To safeguard the rights of all participants, this event requires advance registration. Participants who fail to complete registration by the specified deadline will not be guaranteed a place. Please ensure all procedures are completed in a timely manner.
2. Priority for participation in this event will be given to achievers of the *2025 Annual Performance Awards* and those who qualify for the *Tri-Annual Growth Challenge Incentive Trip*. However, if registration capacity is reached and eligible participants fail to complete registration in time, no additional slots or compensation will be provided. 3. A completed registration form and valid credit card information must be submitted at the time of registration. Product vouchers will not be accepted as a form of payment, unless otherwise announced by the company.
4. The eligibility for this event is personal and non-transferable. If a participant is unable to attend due to personal reasons, it will be regarded as a voluntary forfeiture. No substitute rewards or alternative arrangements will be provided by the company.
5. Once the registration form is submitted, it is deemed as agreement to participate in the full itinerary of the event. Cancellation or refund requests will not be accepted after registration. If a participant is unable to report on time, is absent, or leaves the group midway due to personal reasons, no refund will be issued, and an additional fee of RM3,900 will be charged to cover the event cost difference.

6. Achievers with distributorship registered in Malaysia, for whom international flights are not required to participate in this event, will receive RM500 in product vouchers as an equivalent reward.
  7. For registrants who have completed the registration process but do not meet the events qualifying criteria, an additional payment of RM3,900 must be made by 17 January 2026, Saturday to secure full participation in the event. Failure to make this payment by the deadline will be considered a voluntary forfeiture, and the deposit paid will not be refunded.
  8. As this event involves overseas travel, all participants must ensure that their passports are valid for at least six months from the date of departure. Accordingly, the passport expiration date must be later than 18 September 2026. Participants are required to proactively verify their passport validity and submit a clear copy to the company for administrative processing.
  9. During the event, all departure times, accommodation, and meal arrangements will be centrally planned and coordinated by the company. Accommodation will be based on twin-sharing. Participants who wish to request a single room must indicate this at the time of registration. An additional charge of RM480 per night will apply. Once the request is approved, cancellations or refunds will not be accepted.
  10. For couples who are not under a joint distributorship account, and where only one spouse holds the AGM pin title, an additional fee of RM1,920 (total for four nights) will apply if they wish to stay in the same room and upgrade to the AGM room type.
